III. Approval of the Collective Bargaining Agreement between Envision Education and Envision United CTA/NEA (July 1, 2017 to June 30, 2020)

- Gia informed the EE Board of Directors that the Envision Education Management Team recommends that the Board adopt the Collective Bargaining Agreement between Envision Education and Envision United that will commence on July 1, 2017, lasting 3 years.
- She highlighted that she and the EE bargaining team went into the collective bargaining process with three goals:
 - o Providing the highest quality, innovative program for our students, with teachers and staffing as core to this goal
 - Providing equitable and competitive compensation to attract and retain our amazing staff
 - o Ensuring our financial sustainability
- This agreement reflects those three goals and the core values of Envision Education.
- One of the reasons this CBA is unique is that there is a commitment to strong union management collaboration through forming committees to collectively make Envision better in service of our mission and for teacher effectiveness and sustainability. The committees include:
 - College Success Portfolio Committee to improve Envision's College Success Portfolio process to support teacher workload.

- Health Benefits Committee to make health benefit plan decisions collaboratively moving forward.
- O Shared Curriculum Committee to develop a shared curricular system to increase consistency across all three schools while supporting teacher autonomy.
