I. PRELIMINARY

A. Call to Order

Bob Lenz called the meeting to order at 5:03 pm.

II. COMMUNICATIONS

A. PUBLIC COMMENT/ANNOUNCEMENTS:

Bob Lenz announced that he will present at the NewSchools Venture Fund summit. He then highlighted several recent accomplishments of our schools not limited to, but including, college acceptances of MSAT seniors, impressive CAHSEE pass rates for CAT and Metro, and Envision Schools' first National Merit Scholar - Aaron Kalb.

B. FOR INFORMATION, BOARD/STAFF DISCUSSION

1. Nicaragua Trip Presentation (Anne Raeff and students)

Anne Raeff, Suzanne Motely, Angelica Grisales, and Ana Sanz presented a picture slideshow of the Nicaragua Trip. They highlighted the community service work of volunteering for a disabled students school as a wonderful learning experience. Discussion ensued regarding what students and teachers learned on the trip. Bob Lenz thanked the teachers, Jon Schwartz, and Josh Brankman for all their hard work.

2. Kaleb Lawson Interview (Daniel)

Daniel McLaughlin introduced and presented a video interview with an MSAT senior, Kaleb Lawson. He stated that this was filmed for and shown at the Impact Academy Community Kickoff, where it was incredibly well received. Bob Lenz noted that St. Mary's College gave Kaleb a great scholarship.

3. Enrollment Update (Jon Schwartz)

Jon Schwartz presented an enrollment update. Discussion ensued regarding Envision Academy and use of the Webster Street building in enrollment recruitment. Additionally, Envision Academy's enrollment numbers and a contingency plan was discussed. Daniel McLaughlin noted that Envision has devoted many resources to Envision Academy enrollment and that Oakland Unified School District has changed its policies towards charter schools for the better.

4. Facilities Update (Bob Fyles)

Bob Fyles presented an update on facilities. Daniel McLaughlin summarized features of Metro's new facility at Newcomer High School. He also noted that when Metro students were surveyed, 90% preferred Newcomer to a shared facility in Bayview. Discussion ensued regarding conditional modular permits for CAT. Bob Lenz acknowledged the hard work of Daniel McLaughlin to garner two facilities for CAT and Metro. Bob Fyles summarized the Prop 39 offer for MSAT and the other options on the table.

Bob Lenz stated Envision Schools needs to reply to NUSD's Prop 39 offer by May 11th. He noted that Envision will accept the portion of NUSD's offer with respect to the in district students only. The acceptance will include benchmarks and deadlines. Envision Schools will continue to look for alternatives.
